

ZADEVA: Zahteva po usposabljanju pri uporabi diizocianatov

V povezavi z evropsko uredbo REACH je bila 4. avgusta 2020 v Uradnem listu Evropske unije (EU) objavljena nova uredba 2020/1149, ki prinaša omejitve za diizocianate. Ti lahko povzročijo preobčutljivost dihal in kože, zato uredba zahteva usposabljanje pred uporabo izdelkov, ki jih vsebujejo nad določeno koncentracijo.

Uredba določa, da je potrebno do 24. avgusta 2023 opraviti usposabljanje in pridobiti certifikat za varno delo s proizvodi, ki vsebujejo diizocianate. To velja za vse poklicne in industrijske uporabnike proizvodov s skupno koncentracijo monomernega diizocianata $> 0,1 \%$.

JUB-ovi proizvodi, ki vsebujejo diizocianate in zapadejo novi zahtevi po usposabljanju so:

- JUBIZOL Finish Winter additive
- JUBIZOL Quickfix

Za proizvoda HYDROSOL Polyurethane komp. B in JUBIZOL Finish Winter additive imamo že pripravljeno alternativno recepturo, ki ne bo več vsebovala diizocianatov, vendar izdelki, ki so trenutno na trgu le tega še vsebujejo, zato vas prijazno pozivamo, da poskrbite za ustrezno usposabljanje.

Sicer pa se diizocianati nahajajo predvsem v lepilih in tesnilnih masah, ki se uporabljajo v najrazličnejše namene kot so gradbeništvo, avtomobilska industrija, pohištvena industrija, inženiring, pomorstvo, transport, itd. Vsi ti izdelki, ki zapadejo novi zakonodajni zahtevi imajo to tudi navedeno na embalaži v obliki zapisa: »Po 24. avgustu 2023 se pred industrijsko ali poklicno uporabo zahteva ustrezno usposabljanje.«

SUBJECT MATTER: Requirement for training in the use of diisocyanates

Related to the European REACH regulation, on 4 August 2020 a new regulation 2020/1149 was published in the Official Journal of the European Union (EU), which brings a restriction on diisocyanates. These can cause respiratory and skin sensitization, so the regulation requires training before using products containing them above a certain concentration.

The regulation stipulates that by 24 August 2023 it is necessary to undergo training and obtain a certificate for safe work with products containing diisocyanates. This applies to all professional and industrial users of products with a total concentration of monomeric diisocyanate > 0.1%.

JUB's products that contain diisocyanates and are subject to new training requirements are the following:

- HYDROSOL Polyurethane comp. B
- JUBIZOL Finish Winter additive
- JUBIZOL Quickfix

For the products HYDROSOL Polyurethane comp. B and JUBIZOL Finish Winter additive, we have already prepared an alternative formula that will no longer contain diisocyanates. However, the products that are currently on the market still contain them, so we kindly ask you to take care of proper training.

Otherwise, diisocyanates are mainly found in adhesives and sealants, which are used for a wide variety of purposes, such as construction, the automotive industry, the furniture industry, engineering, shipping, transport, etc. All the products that fall under the new legislative requirements also have this indicated on the packaging in the form of a note: " As of 24 August 2023, training is required for all professional and industrial users."
